2. Provisions of law governing data processing

- Regulation (EU) No. 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: "GDPR");
- Act CCIV of 2011 on National Higher Education (hereinafter: the National Higher Education Act);
- Government Decree No. 283/2020 (VI. 17.) on the introduction of a state of epidemiological preparedness.

3. Processing activities performed by the Controller

The purpose of the processing is the surveying of the health status of students, in the interest of the performance of the public task of higher education, during the healthcare crisis situation, by way of the completion of the questionnaire "COVID-19 statement EN"

In connection with the above, we process the following personal data:

Student's name, citizenship, Neptun code, data pertaining to travels abroad, data related to contacts in connection with COVID-19 infection, to health status in connection with COVID-19 infection, data concerning official quarantine in connection with COVID-19 infection.

The legal basis of the processing is the performance of a task carried out in the public interest, pursuant to point (e) of Article 6 (1) of the GDPR, as well as substantial public interest, pursuant to point (g) of Article 9 (2) of the GDPR.

The duration of the data processing is the duration of the healthcare crisis situation.

The persons having access to the data include the head and staff members of the Registrar's Office; in addition, teachers in charge of lectures and/or practical classes attended by the students may request students to present a copy of their declaration, certified as received by the Registrar's Office.

The declarations submitted to the Registrar's Office shall be stored in the closed Neptun system.

The declarations are evaluated upon receipt, on the basis of the students' stay or visits to other countries in the past two weeks and their statement on exhibiting symptoms of COVID-19 (points 1-5).

The personal data in the statement are not transmitted anywhere.

4. Your rights and the rules applicable to the exercise of such rights

In connection with the processing of your personal data, you have the right to information, the right to request copies, the right to rectification, the right to erasure, and the right to the restriction of processing.

If, in your opinion, the processing is not in compliance with the relevant provisions of law, you may file a complaint with the National Authority for Data Protection and Freedom of Information (postal address: 1374 Budapest, P.O. Box 603, e-mail address: ugyfelszolgalat@naih.hu) to initiate a procedure or may submit your claim to the courts.
