Pursuant to Section 8 (4) of Act CCIV of 2011 on National Higher Education (hereinafter: NHEA), Section 2 (1) of Act XIII of 2021 on the Count István Tisza Foundation for the University of Debrecen, and on the transfer of assets to the Count István Tisza Foundation for the University of Debrecen and to the University of Debrecen, and Act CLXXV of 2011, the Statutes (Deed of Foundation) of the University of Debrecen is hereby issued as follows:

#### 1. The name, registered seat and premises of the University

#### 3. Management and supervision of the University

- 3.1. The proprietor of the University:
  - 3.1.1. Name: Count István Tisza Foundation for the University of Debrecen
  - 3.1.2. Registered seat: 4032 Debrecen, Egyetem tér 1.
- 3.2. The maintaining entity of the University:
  - 3.2.1. Name: Count István Tisza Foundation for the University of Debrecen
  - 3.2.2. Registered seat: 4032 Debrecen, Egyetem tér 1.
- 3.3. The rights and obligations of the maintaining entity
  - 3.3.1. The maintaining entity issues and amends the University's Statutes at its own discretion.
  - 3.3.2. The maintaining entity shall exercise all the rights granted by the relevant legislation in force to maintainers of private higher education institutions operating as public benefit organisations and which are laid down as such in the present Statutes and the University's rules of organisation and operation.
  - 3.3.3. The maintaining entity shall be bound by all the obligations laid down by the relevant legislation in force for maintainers of private higher education institutions operating as public benefit organisations and as set out in these Statutes and the University's rules of organisation and operation.
  - 3.3.4. It shall be maintaining entity's right, with the approval of the board of trustees, to adopt the annual budget submitted by the senate of the higher education institution, the annual accounts and the public benefit report prepared in accordance with the accounting provisions, as well as the higher education institution's asset management plan.
  - 3.3.5. The maintaining entity shall monitor, by way of the internal control function of the University, the financial management, the legality and efficiency of the operation of the higher education institution, as well as the effectiveness of its professional work. For the purpose of monitoring the operation and management of the higher education institution, the maintaining entity shall have the right to access to the institution's academic, management and other records. The board of trustees of the foundation shall have the right of approval when appointing the head of internal audit of the higher education institution.
  - 3.3.6. The consent of the maintaining entity shall be required for the establishment of a title or recognition with a regular financial award under the scope of powers of the higher education institution; for the payment of a regular financial award on the basis of a recognition or title; and for the development of its annual training activities, in particular the courses of study to

- be offered, the methods of organising the programmes, and the planned number of students in each of the programmes.
- 3.3.7. The higher education institution shall determine, with the approval of the maintaining entity, the amount of tuition to be paid for the programmes offered by the institution.
- 3.3.8. The approval of the maintaining entity shall be required for the establishment of a university-owned, either knowledge-utilising or non-utilising type of business organisation, and for the acquisition of shares in such business organisations.
- 3.3.9. The maintaining entity shall be responsible for announcing calls for application to the position of rector.
- 3.3.10. The maintaining entity shall be responsible for appointing the chancellor.
- 3.3.11. In the event of the expiry or termination of the appointment of the rector and the chancellor, the chairperson of the board of trustees of the foundation shall also be entitled to appoint an acting rector and/or acting chancellor until the position is filled.

### 4. Purpose and legal status of the University

- 4.1. Pursuant to Section 2 (1) and (3) of Act CCIV of 2011 on National Higher Education (hereinafter: NHEA), the public benefit activity that the University aims to perform is the pursuance of educational and academic research activities, as well as artistic creation, including in particular tertiary-level vocational training, bachelor's and master's, doctoral and specialized postgraduate programmes.
- 4.2. Pursuant to Annex 1 of the NHEA, the University is a state-recognised higher education institution of Hungary, not a state university.
- 4.3. Pursuant to Section 4 (1a) of the NHEA, the University is a private higher education institution maintained by a public-benefit trust foundation registered in Hungary.
- 4.5. Pursuant to Section 5 (1) of the NHEA, the University is an independent legal person.
- 4.6. The University operates as a public benefit organisation in accordance with the provisions of the NHEA and Act CLXXV of 2011 on the Right of Association, the Public Benefit Status and the Operation and Support of Non-Governmental Organisations and on the basis of the registration of the Education Office.

## 5. The activities of the University

- 5.1. Pursuant to Section 2 (1) and (2) of the NHEA, the University's public task is to carry out educational, academic research and artistic creative activities. In addition, the public tasks of the University are the tasks laid down in point 4 of Annex 1 of Act IX of 2021 on public benefit foundations performing public tasks for the Count István Tisza Foundation for the University of Debrecen, which the law defines as tasks to be performed through the University of Debrecen:
  - a) carrying out higher education activities,
  - b) carrying out health care activities,
  - c) carrying out research and development activities in the fields of agricultural and food sciences,
  - d) performing other teaching related to the educational activity of the higher education institution not included in subsection a),
  - e) contributing to the social and economic development of the region by promoting the dissemination and economic exploitation for community purposes of the intellectual assets stemming from the higher education institution's core activities.
- 5.2. Classification of the main activities of the University:

- 5.3. The core activities of the University:
  - 5.3.1. Providing education in undergraduate (bachelor's), master's, undivided academic programmes, as well as specialized postgraduate training programmes in the areas and levels of education listed in point 7.4, and to issue diplomas in such programmes.
  - 5.3.2. Providing tertiary level vocational training in the field of training defined in point 7.4.
  - 5.3.3. Providing doctoral training and awarding doctoral degrees in the fields of study defined in

point 7.4.

- 5.3.4. In accordance with the relevant provisions of Act CXXXIX of 2005 on higher education, the NHEA, Act CLXXXVII of 2011 on vocational training, Act LXXX of 2019 on vocational training, Act LXXIX of 1993 on public education, Act CXC of 2011 on national public education, and Act LXXVII of 2013 on adult education, engaging in the execution of tasks of higher education, public education, as well as non-tertiary vocational and other training functions as defined in the sectoral laws.
- 5.3.5. In the areas specified in the annex to the rules of organization and operation of the higher education institution, in accordance with applicable separate provisions of law, participating in the training of specialists in medicine, dentistry, pharmacy, as well as specialized clinical psychologists and public health professionals, also including the specialized and further education and training in the area of medicine and healthcare of persons with a higher education diploma in a different area.
- 5.3.6. In the disciplines and areas of training related to its academic programmes, engaging in basic, applied and experimental research and development, science organization, technological innovation, as well as other research projects supporting education.
- 5.3.7. On the basis of the NHEA, participating in the performance of tasks belonging to the scope of healthcare and agricultural economics, in accordance with the provisions of applicable separate provisions of law.
- 5.3.8. As the founding and maintaining entity of primary and secondary level public education institutes, engaging in the performance of public education and vocational education tasks and acting as the maintaining entity of demonstration public education institutes serving the purpose of teacher training. Providing kindergarten and school education for children and pupils with special educational needs who can be taught together with other children and pupils.
- 5.3.9. Operating demonstration plants and demonstration farms for the purposes of practical training.
- 5.3.10. Maintaining a health care service organisation a clinical centre as an organizational unit having its own legal identity for the provision of health care services.
- 5.3.11. Contributing to the preparation of students by transmitting, cultivating and developing national and universal culture and the arts, financial and general entrepreneurship linked to the knowledge economy, and by teaching and developing mother tongue and foreign language skills and talent.
- 5.3.12. Developing and cultivating its international relations necessary for the performance of educational, research and artistic activities at a high level.
- 5.3.13. Engaging in the publication of textbooks and university notes, developing educational materials.
- 5.3.14. For students in its own scope of basic activities, ensuring the provision of textbooks and university notes, library and laboratory services, dormitory accommodation, for the citizens of the university, offering cultural and athletic opportunities, as well as providing services with the aim of promoting the integration, healthy lifestyle and healthcare services for students.
- 5.3.15. Maintaining a library system that participates, as a national deposit library, in the provision of academic and specialized library services.
- 5.3.16. Organising the maintenance and continuous development of the higher education institution's infrastructure.
- 5.3.17. In the interest of discharging its functions, maintaining and operating organizational units for economic management and internal audit, as well as administration, organization, technical services and other functional units ensuring operations, and further, ensuring the organisation of the tasks related to the handling and archiving of documents and public documents in accordance with the relevant provisions of law.
- 5.3.18. Organising admission preparatory and other courses and language examinations
  - Operating a preparatory programme for young people of exceptional musical talent.
  - In the disciplines related to its academic programmes, engaging in cultural organizing and development, as well as artistic, consultancy and other activities.
- 5.3.19. Providing medical, healthcare and public health services not financed by health insurance schemes.
- 5.3.20. Utilizing the free capacities of the higher education institution's infrastructure (especially publishing activities, printing services, the production of printed matters, workplace catering

- and canteen services, the renting out of sports and academic facilities as well as available dormitory accommodation).
- 5.3.21. Performing tasks related to public collections and cultural activities.
- 5.3.22. Cooperating in the development of a national information infrastructure for higher education institutions and research and development.
- 5.4. In the interest of promoting the University's activities as set out in points 5.1 to 5.3., carrying out marketing, public relations and communication activities.
- 5.5. The University' scope of competence and area of operation: the territory of Hungary (and outside this territory).
- 5.6. The University shall not carry out entrepreneurial activities.
- 5.7. The University shall not pursue direct political activities; its organisation shall be independent of political parties, and shall not provide financial support to political parties.
- 5.8. The University has a Public Benefit Supervisory Board in accordance with Act CLXXV of 2011 on the Right of Association, Public Benefit Status and the Functioning and Support of Non-Governmental Organisations, as follows:

  a body separate from the Senate, supervising the public benefit activities of the University, consisting of three members; the chairperson and the members of the supervisory board shall be appointed by the University for a fixed term of one year. Its members have the right to participate in the Senate's discussions. The Public Benefit Supervisory Board shall establish its own rules of procedure. The member responsible for the supervision of student services shall be appointed by the maintaining entity by taking into account the proposal of the University's Student Government.
- 5.9. Other rules relating to the public benefit status of the University shall be laid down in the Rules of Organisation and Operation.
- 5.10. The University may take all decisions and measures in the field of its economic activities which contribute to the performance of its tasks as defined in its Statutes, provided that they do not jeopardise the performance of its basic tasks, in particular: it may enter into contracts, form associations, establish and operate economic entities with the consent of the maintaining entity, use and exploit the assets owned by it and placed at its disposal.

## 6. The leaders, organisation and operation of the university

The duties and terms of office of the University's leaders:

#### 6.1 The rector

- 6.1.1 The highest-ranking official of the University is the rector, who is appointed by way of a public application process, on the basis of the recommendation of the Board of Trustees of the Foundation serving as the maintaining entity, also taking into consideration of the prior opinion of the Senate of the University and is also relieved of duties by the president of the Republic of Hungary, in accordance with the relevant provisions of the NHEA. The rector shall be appointed for a maximum term of five years, which may be extended. The employer's rights over the rector shall be exercised by the maintaining entity.
- 6.1.2 The rector shall be the principal responsible leader and representative of the University and shall act and decide on all matters which are not assigned to the competence of another person or body by the Statutes or the Rules of Organisation and Operation. The rector of the higher education institution may appeal to the maintaining entity against the decision or action of the chancellor or, in the event of failure to act, against the rector's failure to act.
- 6.1.3 The rector shall be responsible for the proper functioning of the higher education institution in accordance with its basic activities, and within this framework shall exercise the rights of an employer over the teaching faculty, researchers and teachers, as well as over the staff of organisational units directly supporting the performance of the duties of higher management, with the exception of the chancellor, and the rights of the principal in connection with engagement contracts. The rector may, with the chancellor's consent, determine the salary and other benefits in respect of such persons working under employment or engagement contracts.
- 6.1.4 The rector may delegate the powers provided for in points 6.1.2 and 6.1.3 to his or

- her deputy or to another executive or senior staff member of the institution, on a caseby-case basis or for a specific range of cases. The holder of the delegated powers may not further sub-delegate such powers.
- 6.1.5 The chancellor shall be responsible for preparing measures and proposals of economic management.
- 6.1.6 The post of rector shall be open to persons with management and organisational skills and experience acquired in a higher education institution, and who hold at least one state-recognised "C"-type (written and oral), general language, complex, or equivalent, at intermediate level (B2) or higher, and who are or will be employed in full time by the higher education institution. To be appointed as rector, the candidate must be employed as a university professor.
- 6.1.7 Relieving the rector of his/her duties requires the vote to this effect of at least two-thirds of the members of the senate. Reasons must be given for such a motion.
- 6.1.8 The rector shall
  - *a*) be responsible for
    - *aa*) national and international educational and research relations and cooperation,
    - *ab*) ensuring that the institution's training programme is in accordance with the relevant legal provisions and the training and output requirements laid down by the competent minister,
    - *ac)* issuing the measures required by law for the amendment of the institution's operating licence, for the launching of programmes, for the registration of doctoral schools and for the higher education admission procedure;
  - b) exercise the right of maintaining entity of a public education institution maintained by a higher education institution;
  - *c)* liaise with interest representation organisations, student and doctoral student self-governments in matters within its competence;
  - d) coordinate the higher education institution's educational and research cooperation with other higher education institutions, national higher education organisations and bodies;
  - e) order an internal audit investigation at the initiative of the chancellor.

#### 6.2. The chancellor

- 6.2.1 The chancellor shall be responsible for the operational management of the University. The chancellor shall act as the head and representative of the higher education institution in respect of the tasks assigned to him/her by the statutes and the rules of organisation and operation.
  - a) be responsible for the economic, financial, controlling, internal audit, accounting, labour, legal, administrative, IT, property management, including technical, facility management, operational, logistical, service, procurement and public procurement activities of the institution of higher education and shall manage the operation of the institution in these areas.
  - *b*) be responsible for the preparation of the necessary measures and proposals in the areas specified in point *a*), and in this context, exercise the right of approval of decisions and measures of the senate and the rector which have economic consequences for the management, organisation and operation of the institution; approval shall be a condition for the validity and entry into force of such decisions,
  - c) ensure, using the resources available to the institution of higher education, that the management of the institution of higher education is sufficient for the performance of its basic tasks,
  - *d*) exercise the rights of ownership in the companies and business organisations in which the institution participates,
  - e) in the performance of the tasks falling within his/her competence, exercise the right of employer over the employees of the institution of higher education on the basis of the rules governing the institution's employment regulations, and ensure that financial and professional competence in accordance with the law is

- guaranteed,
- *f*) ensure the performance of the duties of chief financial officer, delegate the duties of chief financial officer and revoke the mandate of the same,
- *g)* in the performance of his/her duties, he/she shall fulfil his/her obligation to cooperate with and inform the rector.
- 6.2.2 The post of chancellor shall be open to and appointment as a chancellor may be maintained by persons who
  - *a)* have at least five years' leadership experience in a higher education institution and *b)* hold a university or college degree in the field of economics.
- 6.2.3 The chancellor shall be an employee of the institution, with the board of trustees exercising the employer's rights.
- 6.2.4 The chancellor may delegate the powers provided for in points 6.2.1, paragraphs b), d) and e) to an employee of the institution on a case-by-case basis or for a specific range of cases. When delegating powers, the chancellor shall ensure that the senior manager or leader of the higher education institution exercises the powers necessary for the performance of his/her leadership duties. The holder of the delegated powers may not further sub-delegate such powers.
- 6.2.5 In the event of the chancellor's incapacity or inability to act, or in the event of a temporary vacancy in the office of chancellor, the leader designated in the rules of organisation and operation shall be entitled to act as a substitute for the chancellor.
- 6.2.6 Terms of appointment of the chancellor:
  - The operation of the higher education institution shall be managed by the chancellor, who is appointed or dismissed by the chairperson of the Board of Trustees on the recommendation of the Board of Trustees of the Foundation. The term of office is indefinite.

#### 6.3 The senate

- 6.3.1 The governing body of the higher education institution is the senate. The president of the senate is the rector.
- 6.3.2 The senate shall have the powers of the higher education institution as laid down in the Fundamental Law (Constitution) of Hungary.
- 6.3.3 The Senate shall
  - *a)* determine the educational and research tasks of the higher education institution and monitor their implementation;
  - b) adopt the institutional development plan and, as part of it, the research, development and innovation strategy, for a medium-term period of at least five years, specifying the tasks of implementation on an annual basis.
  - *c)* propose the content of the call of applications for the position of rector, and give its opinion on the applications submitted,
  - *d)* accept the following documents of the institution to be submitted to the maintaining entity for approval:
    - da) rules of organisation and operation,
    - db) budget,
    - *dc*) the annual accounts prepared in accordance with the rules of accounting;
    - dd) asset management plan
    - *df*) the institution's doctoral regulations
  - e) determine the institution's
    - ea) system of student counselling,
    - eb) system used for the students' evaluation of teaching activities;
  - f) decide, with the consent of the maintaining entity, on the establishment of a business organisation or the acquisition of shares in a business organisation;
  - g) the Senate shall also decide on
    - ga) the institution's training programme
    - *gb)* the establishment of the academic council and the election of its members and chairperson,
    - *gc)* the ranking of applications for teaching, research and management positions, the awarding of titles and honours,

- *gd)* the establishment and termination of the doctoral school and the start of doctoral programmes,
- ge) initiating the award of national higher education scholarships,
- *gf*) initiating the establishment or termination of a course of study programme.
- 6.3.4 The institutional development plan shall set out the ideas for the development, use, preservation and disposal of the assets placed at the disposal of the higher education institution by the maintaining entity, as well as the expected incomes and expenditures.
- 6.3.5 If a committee or council established by the senate also acts on matters concerning students, it must be ensured that student representatives, with the exception of the credit transfer committee, are also allowed to participate in the work of the committee. The senate shall establish a standing committee to deal with students' academic, examination and social affairs. The participation of students shall be ensured in the committee that deals with student affairs, with the provision that neither the number of students nor the number of members delegated by the higher education institution to the standing committee for the administration of academic, examination and social affairs can be less than twenty-five percent of the members of the committee.
- 6.3.6 Members of the senate, with the exception of student and doctoral student representatives, shall be persons who are employed in a teaching, research or other position in the higher education institution.
- 6.3.7 The members of the senate of the University, with the exception of the rector and the chancellor, shall be elected. All matters relating to the functioning of the senate shall be determined in the higher education institution's rules of organisation and, taking into account the following:
  - a) the Senate shall consist of 71 members, and the members elected by the teaching and research staff, including the president, shall constitute a majority of the members of the body, with representation of teaching staff who are not in a leadership role also being ensured,
  - b) in accordance with the conditions laid down in point, the student government shall delegate representative equal to twenty-five per cent of the number of members of the Senate,
  - c) the doctoral student government shall be entitled to delegate one representative,
  - d) the number of representatives of employees in other positions and of trade unions shall not exceed five percent each of the number of members of the senate, but shall not be less than one,
  - e) general elections to the senate shall be held every four years, provided that
    - *ea)* the senate shall be elected for a term of four years, but the term of office of the representative of the student and doctoral student governments shall not exceed three years,
    - *eb)* if the term of office of a member of the senate ends before the next general election of the senate, an election of an alternate member of the senate shall be held to complete the senate, if no alternate has been elected in the general election
    - *ec)* the term of office of the previous senate or of all its members shall cease on the day of the inaugural meeting of the new senate following the general election,

#### 7.3. The University's

#### 7.3.1. faculties and organisational structure:

The organisational structure and the order of operation of the higher education institution, the division of responsibilities between the leaders, further provisions prescribed by the legislation on internal and external relations are determined by the University's rules of organisation and operation.

As teaching and academic research units, the institute of higher education shall have, in accordance with Annex 1, faculties, faculty-linked institutes, departments, non-independent departments, external departments, doctoral schools, health service providers, practical training organisations of special service providers and a separate research institutes or regional public service training centres.

The higher education institution is divided into faculties. The faculties organize the provisions of the educational tasks in the educational areas and levels according to Section 7.4. The faculties of the University:

- Faculty of Law,
- Faculty of General Medicine,
- Faculty of Humanities,
- Faculty of Health,
- Faculty of Dentistry,
- Faculty of Economics and Business,
- Faculty of Child Education and Special Needs Education,
- Faculty of Pharmacy,
- Faculty of Informatics.
- Faculty of Agricultural and Food Sciences and Environmental Management,
- Faculty of Engineering,
- Faculty of Science and Technology,
- Faculty of Music.

The higher education institution shall have a **clinical centre** for the provision of patient care and health promotion, as well as for practical training, in the form of an organisational unit having a legal personality, which shall be an independent health care provider on the basis of an operating licence issued by the state health administrative body. The health care provider, in accordance with Act CXXXII of 2006 on the development of the health care system and Act CLIV of 1997 on health care, shall provide patient care at different levels of progressivity in the provision of territorial health care services, for which it has a separate financing contract with the health insurance body.

The higher education institution shall have service units for dormitories, libraries, language teaching, IT, schools, nursery schools, kindergartens, nursery schools, day nurseries, publishing houses and translation services.

The institution of higher education shall maintain economic, administrative, organisational, technical service and other functional departments for the performance of its operational tasks.


